## Agenda item: 1 – Welcome

Sonia welcomed the group and highlighted a few items of interest:

- [Additional information](#) has also been published for the updated ELS TAG prior years' service. The new ELS prior year service will move into PROD on 3 December, and the previous version will be deactivated on 31 January 2022. DSPs will have to request access to EVTE and PROD by lodging the appropriate ticket in OS4Ds. No PVT will be required.

The DPO is working to resolve issues with DSP access to both the Knowledge Base and Collaboration Hub in OS4Ds.

## Agenda item: 4 – Changes to payment plan services

Approximately 1 million payment plans worth \$25 Billion are entered into each year; 70% of which are for business clients including sole traders. There has been a 20% increase in payment plans set up via digital channels (esp. OSfA and OSB) since January 2021.

APIs to manage payment plans are available but have seen no take up as yet. Feedback from agents and business clients is that they want to be able to lodge and pay directly through their accounting software, and not have to log into another service or do this manually.

Jim Kneebone gave an overview of the payment plan services which are currently available as well as the proposed changes and enhancements.

## Agenda item: 5 – Delivery update

The September EVTE release occurred two weeks ago – which included the uplifted LDGNN service which now allows NLA for TPAR and bug fixes. The data visibility service and ELS prior years service v2 is being released into EVTE on 30 September.

A number of rollover changes are planned for December. Further details for 2022 will be provided in the next version of the Release on a Page.

The special character updates will be carried out in the client update and income tax services in December.

#### Conformance suite data refresh

Conformance suite test data will be progressively reviewed and updated to simplify impact and streamline implementation. A few super services have already been completed.

The payloads will be published approximately one month in advance of the data moving into EVTE to allow for DSP review and feedback.

### **Agenda item: 6 – Platform update**

There are no current issues with the platforms.

There was some channel degradation on 13 September which led to a minor outage and was due to new security software rollout.

It was also noted that there have been intermittent issues since the weekend deployment resulting in stuck batches. Stuck batches are being replayed.

### **Agenda item: 7 – Agent online environment update**

The quarterly deployment occurred over the weekend without major issues, although it took longer than anticipated.

There was a problem with myGovID on the morning of 28/09, but it was resolved in under an hour.

The BIG has been finalised for the new ELSTagFormat service – it will provide some suggested ways of managing client expectations and some proposed messaging to reduce call volumes to DSPs as well as to the ATO. The BIG will also include some direction around using alternative services such as the lodgment list service, to complete the process of confirming lodgment status.
