Companies Release

The companies release aims to make company registrations easier and more automated, to support directors, secretaries, ABRS and local agents in doing business in a more simplified manner. The design and build is currently underway and is scheduled for **late 2023**.

About companies release

The Companies release will bring together company records administered by ASIC and the ABR on a contemporary digital registry system. The new business register will be a single, trusted, reliable and easily accessible business registry.

Entity data from the following registers will be migrated to join director identity records on the ABRS platform:

- Australian Public companies (from ASIC)
- Australian Proprietary companies (from ASIC)
- Registered Australian Bodies (from ASIC)
- Foreign companies (from ASIC)
- ABN details of the above public, proprietary and foreign companies (from ABR)



New functions and capabilities

- Linking a director ID to a company record.
- Client Accounting Solution to support client billing, invoicing and payments.
- Digital business inbox to support sending digital communication to clients.

Linkages and integration

- Integration to ASIC name determination.
- Checking external role holder details against ASIC registration, e.g. liquidators, auditors, etc.
- Checking banned and disqualified registers.
- Cross jurisdiction data exchange with NZ registry.
- Company ABR data synced back to ABR to support ABN look up and ABR explorer.
- Data feed to ASIC Regulatory Data Repository (RDR).
- BRS and ABN registration APIs will be decommissioned.

Law

- Data standards will be developed to describe the data to be collected by the Registrar.
- Disclosure framework will be developed to define what information the Registrar can release, to whom, and how that data may be used.
- MOUs and other data sharing agreements.
- Law change will also be required to support key identified transformational opportunities.

Data migration

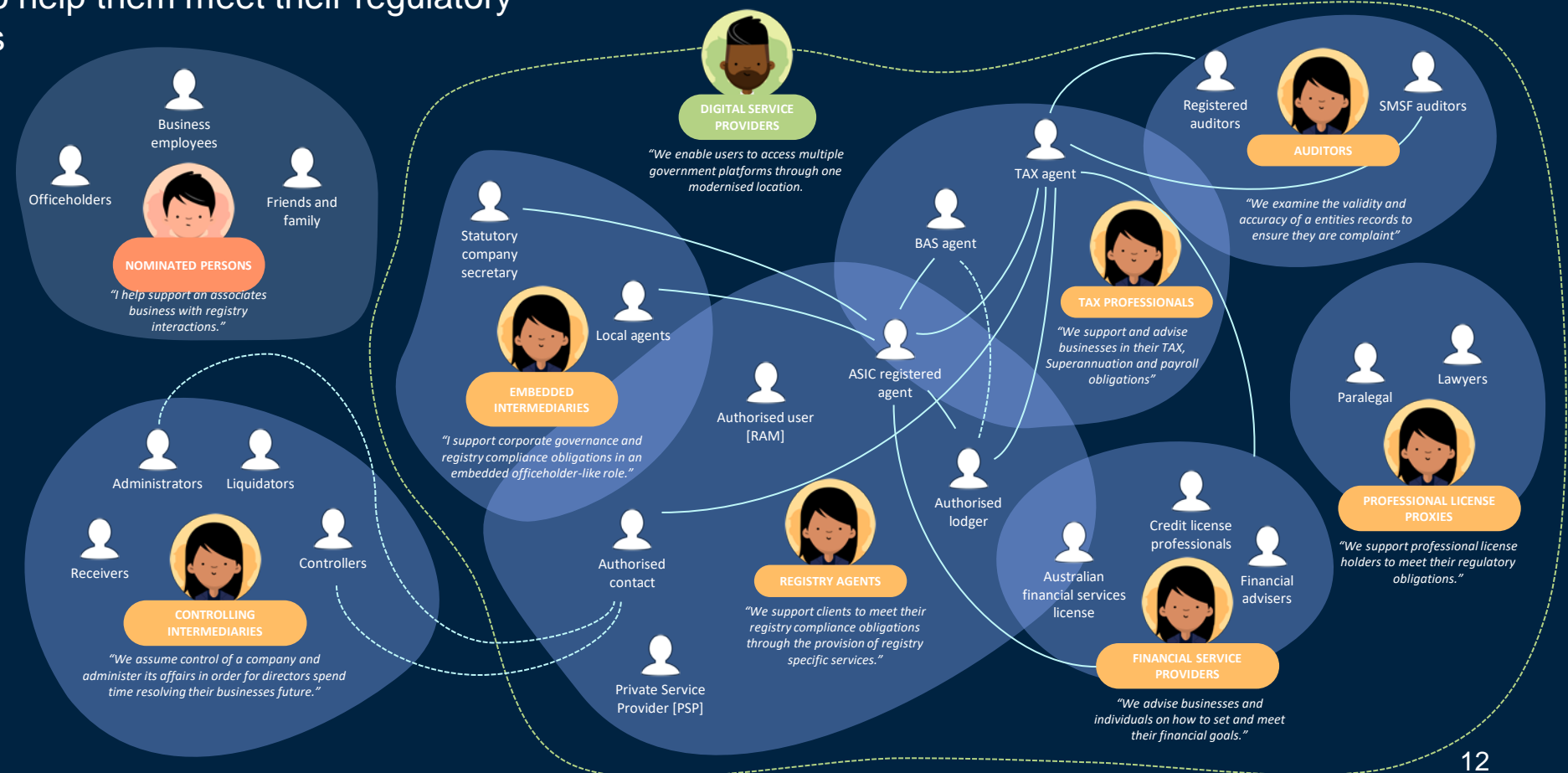
The Companies release also requires the migration of historical and current registry data from ASIC and ABR into the newly built ABRS register.

This migration means that on day one, companies can interact with their current registration details and other data users can search and access the registry.

The role of intermediaries

Draft map of intermediaries

Intermediaries capture a large number of industries. They can be defined as professionals who provide services and advice to businesses to help them meet their regulatory and registry obligations



The role of Intermediaries in modernisation

Registered agents, DSP and third party intermediaries are **key registry users who help clients meet their registry obligations**. They provide expert and knowledgeable advice and services and act on behalf of clients, including providing value-added products and services.

Intermediaries are recognised as valuable enablers – this group supports voluntary compliance and is critical to MBR's success in delivering on program outcomes.

We would like to work with you to shape the ABRS agent model of the future.



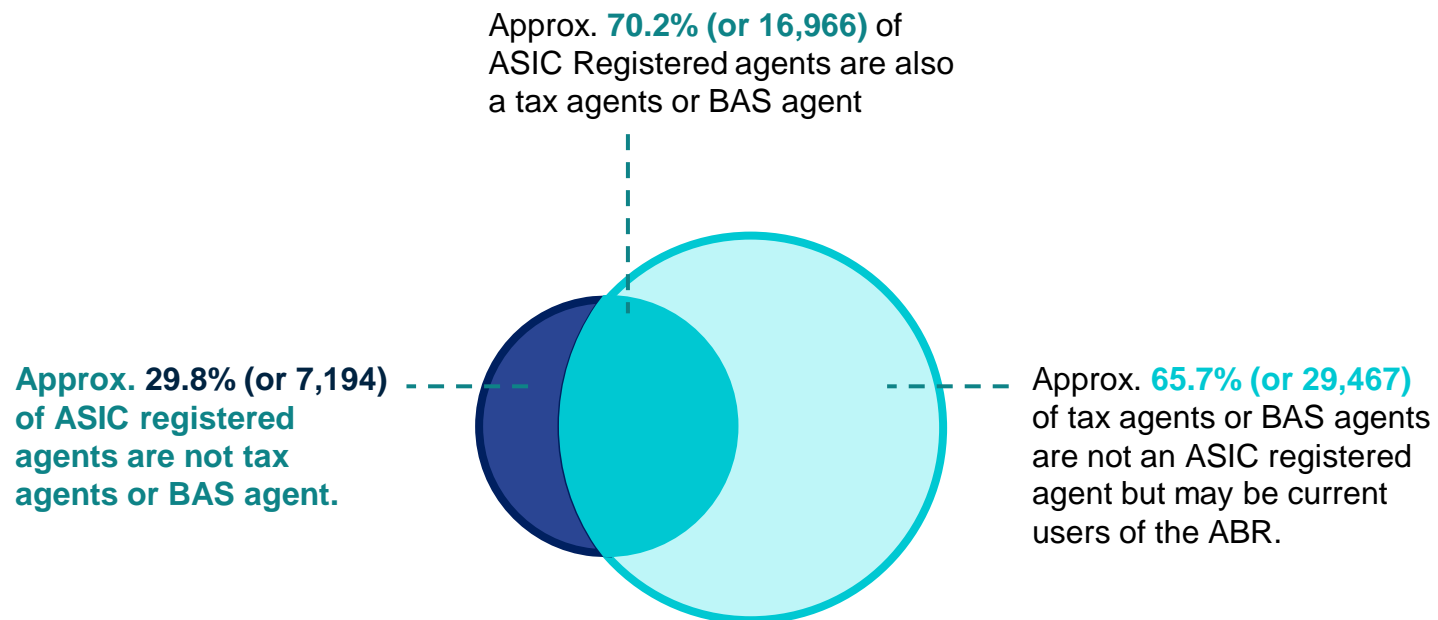

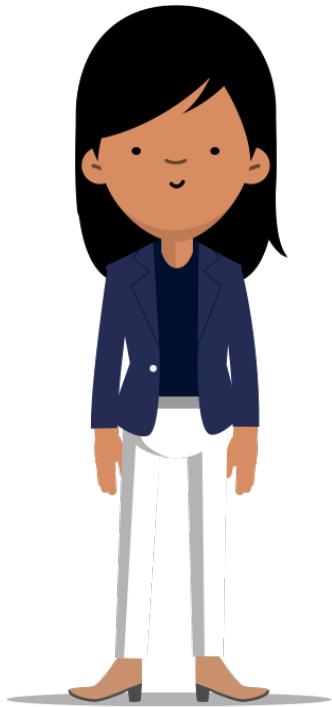

Across general tax and BAS agent registrations and the agent practice model, approximately **198,000** people are employed as a tax agent within a practice and approximately **37,000** are employed as a book keeper in a BAS agent practice.

ABRS agent key facts

ABRS agents will be a key user group who support voluntary compliance and are critical to the success of the MBR program.



The new ABRS agent model will consolidate existing ASIC and ABR agent functions into one single agent role type. ✓

They will be able to access registry services in one place and require a single credential to log in and act on behalf of their clients. ✓

ABRS agents will be supported to deliver registry services to their clients through tailored agent services in ABRS online and through software. ✓

ABRS agents will not be governed under the Tax Practitioners Board (TPB).

The intent of the ABRS agent model is to cover those who are **providing registry services for a fee** on behalf of clients, regardless of whether they're solicitors, tax agents etc.

ABRS agents **will not** be able to perform tax and superannuation functions via ABRS (unless they are a registered tax or BAS agent).

About ABRS agents

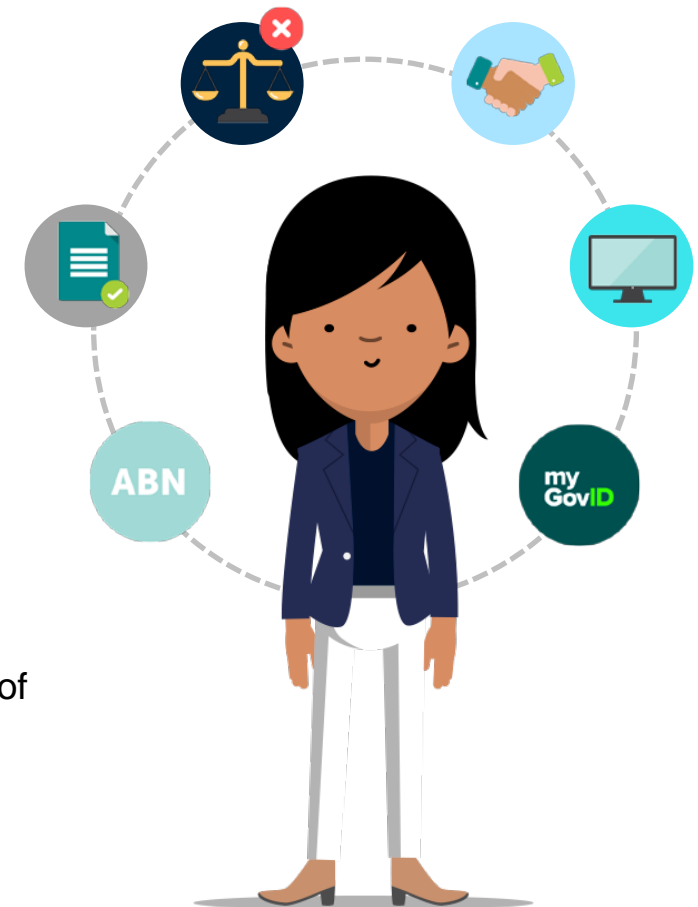
ABRS agents will be authorised by registered Australian businesses to register companies and maintain their information, pay fees, receive notifications and may provide other administrative services to business.

To do this, an ABRS agent **must**:

- ✓ be a business with an ABN
- ✓ have been registered to become an ABRS Agent
- ✓ have an ABRS agent identifier
- ✓ have a “responsible person” with a myGovID
- ✓ agree to and comply with Terms and Conditions governed by ABRS
- ✓ have an agreement (off-ABRS) with their client(s) to interact with ABRS on their behalf
- ✓ interact digitally.

An ABRS agent **may**:

- ✓ have staff within their business that they have delegated agent permissions to on behalf of their clients
- ✓ have multiple intermediary role types, such as also being a tax agent, accountant, ABR authorised contact and others.
