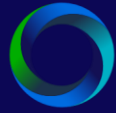

# What are ABRS API Products and how are they used?

- The ATO's Digital Service Gateway introduces the concept of Product Groupings.
- ABRS APIs are bundled into service offerings or Products for consumption by DSPs.
- A product is a grouping of APIs that have similar or inter-related functions.  
E.g. APIs to register different company types are grouped the Company Registration Product.
- Registering to use one or more products will grant access to all the APIs in that product.
- API Scopes, specified during registration, provide additional control over access to APIs, in combination with products.
- API risk ratings are rolled up to a Product risk which affects the onboarding requirements set by the ATO's Digital Partnership Office.

# The ABRS API Product Descriptions

Following Product groupings are proposed – For Discussion.

Product Name	Summary of Product Function (Business working on formal descriptions)	API Count
Company registration and name reservation	Provides all the APIs needed to register different company types (E.g. public, proprietary) along with APIs that register Business Name and ABN. Includes the Dashboard APIs to check transaction progress.	12
Company maintenance	Includes all the APIs needed to maintain company and principal details. Includes APIs for general lodgement, CTR and dashboard functions.	19
Company entitlement maintenance	A maintenance product focused on APIs for ABN information and company entitlement management (contacts, public officers). Includes APIs for CTR and dashboard functions.	7
Agent services	Includes APIs that are used by Agents to manage obligations for companies they act on behalf of, e.g. Get Details APIs, correspondence management APIs, Transaction retrieval APIs, Annual Review Date Retrieval and dashboard APIs.	15
Entity search - Data	Includes all search APIs that provide basic company data. E.g. Search Public Entity Register and Free Current Company Extract	6
Entity Search - Extracts	Includes search APIs that return more detailed or specialised company information, E.g. Certificate of Registration of a Company, Current Company Extract and Current and Historical Company Extract APIs.	13
