# **Agenda Item 2: Peppol Authority Updates**

## **Accreditation progress**

- Comarch, SNI Teknoloji and CBS Corporate Business Solutions recently accredited.
- Australia has 41 accredited service providers and New Zealand has 37.

#### **A-NZ BAU Framework Updates**

- Biannual releases:
  - November 2022 release (v1.0.8) became mandatory on 6 February 2023.
  - May 2023 release
    - No significant changes expected to Invoice; will include changing PEPPOL-COMMON-R050 rule (ABN validation) 'Warning' to 'Fatal'
    - OpenPeppol held a webinar on the changes on 13 February about the 6 proposed changes to eProcurement documents.
    - OpenPeppol are trialling a new consultation process using a webinar rather than survey.
       Initial feedback has been positive.
- Advanced Ordering:
  - New specs were published on the Peppol eProcurement site (<a href="https://docs.peppol.eu/poacc/upgrade-3/">https://docs.peppol.eu/poacc/upgrade-3/</a>) and are available for implementation.
- eDelivery code lists:
  - Code list v 8.3.1 was released on 23 January 2023; email sent from OpenPeppol. https://docs.peppol.eu/edelivery/codelists/index.html

- Held on 7-8 December. Main discussions were around CTC and expanding elnvoicing globally.
- PAs also attended meeting on 9 December with other regional PAs or countries looking to become Peppol enabled in the Asia Pacific region.
- Dubai Exchange Summit held on 20-21 February, understand discussions similar to Singapore.

# Agenda Item 4: OpenPeppol Activities

#### **Peppol Community Updates**

- APP CMB Update from Craig Smith and Simon Foster
  - First amendments to the Internal Regulations s will likely be out for consultation in May.
  - Reporting BIS policy will hopefully be out for consultation next month.
- eDelivery Community Update by chair on behalf of Elly Stinchcombe
  - eDec met on 16 February.
  - End User Reporting BIS consultation received ≈40 comments. An information preview will be provided to address.
  - Elly and Philip provided updates at the OpenPeppol SP community meeting recently.
  - Next meeting scheduled 3 March.
- No updates from the General Assembly and PoACMB.

#### **Open Peppol Working Groups**

- Peppol Security Requirements Design
  - Drafting of detailed documentation is continuing. Next meeting scheduled 6 March.
- Reporting BIS Consultation (End User and Transaction Statistics)
  - AU PA responded to End User Reporting BIS Consultation, and raised that there is still
    outstanding issues with Transaction Statistics Reporting BIS such as completeness of data.
- Logistics Domain
  - It is being proposed that Logistics could be a new domain within OpenPeppol.
  - Project scope includes setting that up and determining processes to ensure ongoing alignment with Post-Award specifications.
  - The first meeting was held 15 February.
  - Looking into new specifications for:
    - Fulfilment

- Advanced Despatch Advice with and without Response.
- Weight Statement.
- Receipt Advice (proposed).
- Transport (proposed)
  - Transport Execution Plan (stand-alone and in response to a Request)
  - Waybill.
  - Transportation Status (stand-alone and in response to a Request).
- Order/order response/invoice are not part of Logistics
- Contact OpenPeppol if you want to join the Project Group.
- Peppol International Invoice
  - The team gave a presentation on PINT as a Pre-consultation on impacts to the AU/NZ environment to feed into upcoming OpenPeppol consultation.
- Message Level Acknowledgement
  - Currently reviewing how Service Providers use the MLR.
  - Further reviews of BIS Billing and Invoice response will be done in June/July 2023.

# **Agenda Item 5: Adoption Update**

#### Reporting

The AU and NZ December dashboards were provided to the forum prior to the meeting.

#### **New Zealand**

- Over 7500 registrations.
- Priority this year is to get invoice volumes up.
  - A large number of large senders have committed to sending elnvoices, including large a telecommunications provider who has committed to send elnvoices later this year.
- Central Government:
  - Ministry of Business, Innovation and Employment (MBIE) now prefers to receive all invoices via elnvoicing.
  - Held an event on Dec 7 for Central Government agency CFO's which has helped to drive new momentum. Several key agencies are now beginning their outreach communications to their suppliers to inform them of their preference to receive elnvoices.
  - Another Central Government agency CFO elnvoicing event is scheduled for 30 March, with the Minister for Small Business looking to attend.
- Local Government:
  - 2 Councils now on board with more planning to be enabled soon.
  - Attending and speaking at the upcoming Taituara Strategic Finance Forum.
  - Please contact us directly if you're planning any work with Councils in New Zealand.

Software/elnvoicing Ready:

- 33 software products on the elnvoicing ready product register.
- Planning a joint communications campaign and webinar with the ATO in May to promote awareness among DSPs.
- Please continue to encourage any software providers you work with to apply to be part of the elnvoicing ready list.
- Communications and Marketing:
  - Advertising continues to build on awareness and understanding and to convert awareness to registrations.
  - In third week of February, we ran webinars to CA ANZ (NZ members) NZ bookkeepers and small businesses who subscribe to the Digital Boost platform (a MBIE initiative to increase digital capability amongst businesses).
  - Piloting an eDM to businesses registered on Peppol network encouraging them to get their suppliers to send them elnvoices and pointing.
  - Heavy focus on assisting MBIE to get their own suppliers to send elnvoices.
- Recruitment Sector Update
  - MBIE and the ATO are taking a joint focus on the recruitment sector, due to the high proportion of government invoices from recruitment companies.
  - This is a joined-up approach working with software vendors, RCSA (industry body) and directly engaging recruitment companies.

#### Australia

- Small Business
  - Held 3 webinars in November, December 2022 and February 2023.
    - Webinars targeted existing users of software as they are more likely to adopt.
    - Had very good engagement with 1,100 participants registered and over 500 attended.
    - Considering expanding the scope to include all SMEs and relevant elivoicing Ready solutions and continue holding on a monthly or bi-monthly schedule.
- Large volume senders/billers
  - Continuing engagement with energy retailers interested in adding elnvoicing capability as part of their implementation of the Better Bills Guidelines.
  - Commencing initial enquiries into water utilities and construction with a view to leverage
     2022 engagement with energy retailers & major DSPs in the industry.
    - If you have experience or provide SP services to water utilities or construction, we
      welcome your insights to help us understand these industries and identify best adoption
      opportunities. Please contact elnvoicing@ato.gov.au.
- Regional elnvoicing Hubs
  - Working with a local council to establish a hub that will run awareness activities and champion adoption in their area. It will include large businesses and SMEs, industry associations and business groups, government agencies and trusted advisers, all of which are closely linked with the business community in the area.
  - The intent is to kick-start organic adoption and achieve network effect in this ecosystem to see how this can be scaled.
- Case Studies/ Testimonials

 Looking to expand our library of case studies or testimonials of client's experiences of using and enabling elnvoicing. If you have any that you have received from your clients and are able to share, we would like to add them to our website.

#### Federal Government

- All new tenders have elivoicing as their preferred payment method.
- Primary focus on supplier onboarding, especially large Whole-of-Government suppliers.
- Working with Finance, Treasury and Services Australia on policy levers and technology change plans (eg. RMG417 refresh, payment times reporting and GovERP).

#### State Government

- 200 state and territories entities enabled.
- Since last meeting, VIC, WA and QLD agencies have come on board. Their enablement will be slower than NSW and SA as they have Shared Services hubs (the consolidation of Government operations that are used by multiple parts of the same organisation).
- Local Government:
  - Hoping the regional hubs will help encourage councils to enable.
- Digital Service Providers
  - 35 eInvoicing-Ready products now available.
  - Surveyed elnvoicing-Ready providers to understand capability of software and planned improvements in the next 12 months.
