Agenda item 1 - Welcome

Agenda item 2 - Action item updates

There are currently no open action items.

Agenda item 3 – Tax time related documentation

Software Developer Website updates:

Cents per Kilometre Deduction Rate for Car Expenses has been updated to include the rate for 2023/24 of 85c.

Collaboration Hub updates:

We have now received Royal Assent for the Medicare level low-income threshold. <u>Medicare levy and Medicare levy surcharge thresholds page</u> has been updated to reflect this.

There have been multiple updates to the <u>Rates and Thresholds table</u>, with further updates occurring throughout this week.

<u>Tax time 2023 FAQ page</u> has been updated - Validation rules that block lodgment of CTR, PTR, TRT, TRTAMI and IITR when the payload contains either of the two small business boost labels have been removed.

Change Advices

CA2023-012 Small business skills and training boost

An updated change advice is now available in Online services for DSPs. This affects SBR, online services, paper forms and income tax software.

CA2023-013 Small business technology investment boost

An updated change advice is now available in Online services for DSPs. This affects SBR, online services, calculators, paper forms and income tax software.

CA2024-002 FBT employee declaration updates

Amendments to the Fringe Benefits Tax Assessment Act 1986 (FBTAA) have been proposed. The Bill is currently before the Senate and has not yet become law. This affects FBT software. A change advice is now available in Online services for DSPs.

Changes to fringe benefits tax record keeping

The government previously announced a proposal to provide the Commissioner of Taxation with the power to allow employers to rely on alternative records to finalise their fringe benefits tax (FBT) returns. This measure is now law. It applies to the 2025 FBT year (1 April 2024 to 31 March 2025) and onwards. More information can be found here Changes to fringe benefits tax record keeping. A Change Advice will be published as soon as it is available.

Agenda item 4 – Update on general matters and Tax time delivery

Whitelisting for TT2023 services for all DSPs who have passed PVT has now been completed, and confirmation provided in the ticket.

Confirmed with DSPs that Income Tax Returns with Small business boost labels can now be lodged via SBR. The validation was removed and went into production on 29 June 2023, this impacted the CTR, PTR, TRT, TRTAMI and IITR services.

Salary and wages occupation code issues are being investigated to address the anomalies with the MST and codes published in Collaboration Hub. There will be further communication with a work around published in the coming days.
