## Agenda item 3 – Tax time related documentation

**DSP Hub updates:** This new [DSP Hub](#) landing page is now live. This is a consolidation of the Collaboration Hub and Knowledge Base pages.

A link to the [Salary and Wage Occupation codes](#) available on ato.gov.au has been added to the [Rates and Thresholds table](#). It is noted that this list still has the [6 codes](#) identified as being end dated listed. The business area responsible is logging publishing request to get these removed.

## Agenda item 4 - Update on general matters and Tax time delivery

Remaining tax time PVT tickets will be closed over the next few weeks after verification checks have been completed. This will be communicated via the ticket.

A reminder that full PVT is required for AS 2023 if you are transitioning from SBR1 to SBR2 channel.

PVT requirements for the new AS2023 service

### AS.2023.submit service

- for those who are transitioning from the 2009 to 2023 version, light PVT (5 activity statements) will be required to be undertaken.
- DSPs transitioning from SBR1 to SBR2 will need to provide full PVT. In the whitelisting request, fully documented scenarios will need to be attached as evidence.

We may ask to work with some early lodgers for BDV purposes.

## Agenda item 5 - Improving SBR2 error messages

Nathan Booth presented a [pack](#) which showed the upcoming continuous improvements to SBR2 error messages addressing irritants and causes of stuck batches.

One of the improvements will resolve the partyID validation error in the eBMS3 header. Previously, if an invalid character is provided in the payload, the AUTH 11 error code would be generated, and the lodgment would require manual intervention by ATO staff. There are now 4 additional error codes which will be returned to the Tax Agent/Intermediary with full description of the issue. There will be impacts to Conformance suites due to the improvements to the Client ID algorithm checks. These will be updated in the appropriate area within ShareFile, please **see pages 8 and 9 of the [presentation pack](#)**.

The major EVTE PAYEVNT release was completed in July. The release includes Payevnt Adjustment and Payevnt List services including the final conformance suite package as well as new on-demand reports – ITCRPT v2 and ASLRPT v2.

The PAYEVNT Adjustment service will have additional scenarios added to the conformance suites in the upcoming August EVTE release.

A reminder that we have updated the client update conformance suites in relation to making updates to the identifiers. This only impacts EVTE.
