### Agenda item 2 - Action item updates

# Agenda item 4 - Update on general matters and Tax time delivery

The <u>Tax time 2024 PLS Additional Information FAQ</u> page on the DSP Hub is in the midst of being updated to provide advice about the published final <u>2024 Company tax return</u> form which does not reflect the increase in digits from 11 to 15, as mentioned in Change advice <u>CA2024-018 Large dollar values for Company tax return 2024</u>. The increase of digits on the Company tax return paper form is anticipated to occur in 2025.

There is no requirement for PVT for Tax time products if you are an existing DSP who has:

- provided a similar service in the previous year
- no outstanding quality issues
- remained up to date with Operational Security Framework requirements.

NITR and IITR whitelisting is anticipated to commence on 20 June 2024. If there are any changes to this date, it will be communicated prior.

## Agenda item 5 – Delivery update

The next EVTE deployment is scheduled for 8 June 2024, with publication of artefacts on 6 June 2024. The release will include updates to remove redundant trust validation rules relating to assessment calculation code and address check.

July EVTE will include a LCMSF update.

## Agenda item 6 - Platform update

All platforms are currently operating as normal. SBR2 incident occurred on 28 May 2024 resulting in intermittent failed single transactions.

Tax time activity and capacity planning is in progress, an update will be provided at the next meeting.

### Agenda item 8 - DSP communications update

An overview of the upcoming newsletter content was shared with the group. Key updates included:

#### **Tax Time 2024 certification process**

The latest Tax Time 2024 SBR artefacts <u>Individual Income Tax Return (IITR) 2024</u> and <u>Non-Individual Income Tax Return (NITR) 2024</u> are available on the SBR website. To comply, you must perform final tests based on the latest specifications and artefacts. After completing testing in EVTE, submit a 'Request production access' ticket via the DSP service desk.

There are no product verification testing (PVT) requirements if you are an existing DSP who has:

- provided a similar service in the previous year
- no outstanding quality issues
- remained up to date with Operational Security Framework requirements.

We'll monitor production transmissions during the safety net period after the tax time release and notify you via your DSP service desk ticket once your product is certified.

#### DSP service desk - raise the right ticket to avoid delays

When raising a ticket via the DSP service desk, it's important you select the right ticket type for your issue to avoid delays in processing your request:

- Raise a <u>Report an incident</u> ticket when you want to report a technical issue or an error in a document e.g. specifications.
- Raise an <u>Ask a question</u> ticket when you have a question about a system, service or consultation.

We encourage you to select your ticket type carefully. If you select the wrong one, we'll need to close the ticket and ask you to create a new one, leading to longer resolution times.
