Agenda item 1 - Welcome

In line with best practice, the ATO is introducing a new requirement for members of all ATO consultation groups to complete an integrity declaration. Given the unique nature of consultation matters, a declaration is required for each group that a DSP is a member of. Members of ongoing groups will be asked to sign a declaration annually. Members of groups with a defined end date or outcome will sign one declaration to cover the duration of the consultation. Integrity declarations will be sent to DSPs shortly and need to be returned by 30 September 2024.

DPO will note DSPs request to allow sufficient time for their legal team to review the integrity declarations prior to signing and returning to the DPO.

IITR and NITR PVT tickets will be closed shortly.

Agenda item 5 - Delivery update

August EVTE will include the following:

- LDG Get rollover for 2024 full EVTE package and Conformance Suite updates
- TSL rebranding updates for LDG Get, IITR and IITR Prefill

The Department of Employment and Workplace Relations expanded the Trade Support Loans (TSL) program to include apprenticeships and traineeships, now known as the <u>Australian Apprenticeship Support Loans</u> (AASL). This change came into effect on 1 January 2024, and we are currently updating our products and contents to reflect the new terminology for 1 January 2025.

To minimise DSP impacts to production services, the following changes are being made:

- IITR Prefill will have updated labels and guidance changes for the 2024 service. From 2025, a new generic SBR data element with specific guidance will be introduced to reflect this loan type. Draft artefacts for IITR Prefill will be available in August EVTE.
- Reference data for AASL will apply for all prior years and current year in ASMT Get.
- CLNTACC and CLNTACCSUM services will move the Tax Type Account Codes from enumerated lists in the schema to a validation rule. This change enhances flexibility for updates when necessary and minimises the impact on DSPs.

SMSFAR.0013 2024 Business Implementation Guide draft version 0.2, and the Partnership tax return 2024 (PTR.0012) as final v1 were published on 25 July.

Some agents are experiencing an issue with lodging general purpose financial statement lodgments in OSfA. There is no work around for this issue, work is underway to provide a resolution as a priority and communications are being developed. Though lodgments are due 31 July, failure to lodge penalties will not be applied in these cases.
