# Agenda item 3 – Tax time related documentation



The following updated Change advices have been published in the DSP Hub:

#### 21 January 2025:

CA2025-005 Increasing the integrity of the foreign resident capital gains withholding regime

#### 23 January 2025:

CA2025-007 Personal income tax - Exempting lump sum payments in arrears from the Medicare Levy

#### 28 January 2025:

CA2025-001 Multinational Tax Integrity Package - improved tax transparency (Public CBC reporting)

# Agenda item 5 - ASLRPT and ITCRPT 2023 discrepancy solution options

The group decided to go with solution option 2 for ASLRPT and ITCRPT 2023: **Update MST and schema to align with current response.** 

Update the ASLRPT/ITCRPT 2023 MST and schema to align with the service response.

#### DSP impact:

- Updates to MST (update nesting of information and XML-Xpath) and schema
- Minor version update of the schema.

#### Pros:

- No impact service response (including CS response) in EVTE or Production
- No impact to conformance testing or whitelisting.

Cons:



DSPs will need to consume the latest schema version and regression test.

Discussions confirmed this is not a breaking change as the structure of the message will not be amended. This proposal will see the MST and Schema aligning with the current structure of the service response message.

# Agenda item 6 - Delivery update

February EVTE: 6 February publication and 8 February code deployment.

Activity statement 2025 service: Artefacts Package - MSTs, VRs, and Schema

#### 2025 ITR services:

- Housing build to rent changes
   – Artefacts MST and schema will be available for CTR, PTR, TRT,
   TRTAMI and TRTAMIS code for all impacted services in future EVTE release.
- Thin capitalisation and debt deduction changes IDS MST, schema, VR, CTR, TRT and TRTAMI MST changes. PTR – MST and VR changes. DTA country code changes for IDS planned for March EVTE.
- Small business energy incentive and skills and training boost removal for PTR.
- SMSFAR 2025 Rollover of the initial SMSFAR 2025 service, Better Targeted Super Concession (BTSC) label changes – Accumulation phase value and Retirement phase value updated to Value of accumulation account and Value of retirement account - MST/taxonomy only.
- Currency code updates for CTR.
- Alignment of industry codes for CTR, TRT, TRTAMI and IITR.
- Removal of Obsolete preservation age Label F From 1 July 2024 nobody will be 'above preservation
  age but below 60' when doing their 2025 tax return. Anyone born after 30 June 1964 has a
  preservation age of 60. Label F is now obsolete and needs to be removed. IITR MST and VR removal.

**2020 service:** Client communication 2020 List service changes to include a new delivery channel "ATO app" – Feb EVTE and Prod now in June 2025 (previously communicated as May 2025).

#### March EVTE: 28 February

IDS Schedule – updates to the labels for the Schema and VRs.

An updated Digital Wholesale & Integration Services (DWIS) <u>Product and Program Delivery roadmap</u> will be available in early February.

- Unplanned outage for SBR2 on 19 January 2025 which was addressed quickly
- SBR will stop accepting TLS 1.0 and TLS 1.1 in PROD by 1 February which is on track as per comms sent out from the DPO.

# Agenda item 9 – Activity Statement 2023 service remediation working group update

**First meeting held on 28 August 2024:** Introduced the ATO team, discussed options on remediating the AS2023 service

**September 5:** After TT event, held a workshop in Canberra to discuss the preferred option – build a new service

**19 September:** First insights into the technical artefacts and XML schema, requested feedback at this stage

31 October: Discussed feedback on the first draft technical artefacts for AS2025

**16 January 2025:** Discuss the finalisation of the AS2025 service design intent and the updated conformance suite test case scenarios

Core build of the new AS2025 service has been completed, and ATO internal testing currently in progress

The project is progressing as per the plan with delivery of AS2025 on track for March EVTE release, and PROD release in June 2025

The group requested confirmation of the deprecation of AS2009 service, which is currently noted for 31/12/2026.
