Agenda item 4 - Update on general matters and Tax time delivery

DSPs were reminded about FBT whitelisting and to log a ticket for PVT. Whitelisting date is to be confirmed, however go live will be 1 April 2025.

A DSP noted when attempting to raise a ticket for FBT whitelisting, they received a return message to try again after 1 April 2025. This issue has now been resolved and learnings have been passed on for future reference.

Bugs for ASLRPT/ITCRPT are being discussed internally, clarity surrounding the dates for EVTE and PROD are anticipated to be shared in the next PLSWG.

Agenda item 5 - Delivery update

March EVTE deployed over the weekend, with publication occurring on 5 March 2025:

- Updates to TRT, TRTAMI, PTR, CTR, SMSFAR, IDS, AS 2025 services.
- FBT finalisation of artefacts. Going into production this weekend.
- Service Registry was also updated to reflect 'fit for build' status for FBT2025

The <u>ATO Common Business Implementation and Taxpayer Declaration Guide</u> has been updated due to a DSP query regarding the flow of a return and who can sign the declaration last. The update provides guidance and clarity on the legal requirements and end-to-end process for making declarations.

Consultation on Client agent linking and what this will look like for sole traders and individuals is anticipated to commence soon.

- Chief Information Officer and branch realignment:
 On 11 March 2025, Mark Sawade commenced as the Chief Information Officer and Chief Security
 Officer. Mark brings a wealth of expertise and experience from across the broader APS, making him well placed to lead the ATO's technology and security functions.
- Lump sum E reporting: \$1,200 threshold removal from 1 July 2025.
- ASLPRT and ITCRPT version 1 validation rule error:
 VR.ATO.ODRPT.000013 (Report Type is invalid) is being returned in error when requesting client specific reports in version 1 of the on-demand reports ASLRPT and ITCRPT. Until a fix can be implemented, the report should only be requested for whole-of-practice.

We're working on implementing a fix to enable client specific report requests.

• Logging in to our online services will soon be a little different.
