Exempting lump sum payments in arrears from the Medicare Levy, based off a 2023–24 Budget measure. It will ensure low-income taxpayers do not pay higher amounts of the Medicare levy as a result of receiving an eligible lump sum payment.

- AS2025 improved error messaging in the external Validation Rules
- NITR2025 Validation rules updates and code deployment for Housing build to rent for TRT, TRTAMI, and TRTAMIS
- IITR2025 Removable fields associated with obsolete preservation age label from 2025

Agenda item 6 - Platform update

There were no critical platform issues in the last fortnight.

Agenda item 7 – Agent online environment update

Integrated March release occurred between 14 March 2025 and 17 March 2025. See Key changes Australian Taxation Office for agents.

Changes included:

- <u>Card payment system upgrades</u> to enhance security and fraud detection, removing card payment
 options in Online services for agents (payment options such as BPAY and electronic funds transfer
 remain available).
- The 'Make payments' permission was removed in Access Manager for Tax and BAS agents to support the removal of credit/debit cards from payment options for one-off payments.

The final Transition to exchange (T2E) also occurred over these dates, introducing an additional screen for users to consent to sharing their details with the ATO online services they are accessing i.e., Online Services for Agents (OSFA).

Internal reviews of the PLS user guide and BIGs are underway in preparation for Tax Time.

Agenda item 9 - DSP feedback

DSPs were advised to raise a ticket to have the following items investigated:

- A discrepancy in BICs in CTR and TRT, leading zeros are missing, resulting in breaking validation rules
- Inconsistencies in numerical references across draft PDF forms. Some draft forms are using words rather than numerals, or vice versa. Will there be consistent updates made across forms?
 - Update: The latest version of the ATO style guide instigates a change to the style used for numbers and measurements, improving accessibility and readability.

Numerals for 2 and above in text

Previously in general text, we wrote 'one' to 'nine' in words (except when accompanied by a symbol) and used numerals for 10 and above. Research shows that numerals are generally easier to read and scan, so this advice has changed.

In general text, including headings and subheadings, we now use:

- numerals for '2' and above
- words for 'zero' and 'one' (to avoid confusion with the letters O and I).

These changes will progressively filter through to all forms.
