Agenda item 5 – Delivery update

July EVTE deployment occurred on the weekend of 19 July.

In the [1 July PLS working group meeting](#), an overview was provided to members relating to the LDG List implementation for OECD Pillar 2 changes. After the meeting, members provided feedback and chose option 1, resulting with keeping the existing LDG 2023 service and relaxing the MST and schema.

Two high severity bugs have been deployed for the PTR return 2025:

- 1 July – fault from agency error - correctly addressed and fixed as emergency change
- 10 July - bug returning a PTR 431002 error has been resolved and in production

Draft specifications have been sent to members of the 'Australia's adoption of the Implementation of global minimum tax and domestic minimum tax working group' (Pillar 2) group relating to two services impacted by Pillar 2 changes. Members were offered to be sent these draft specifications if interested.
