1 September

<u>CA2026-001 Critical Minerals Production tax incentive (CMPTI).pdf</u> (Future Made in Australia – accelerating investment in Australian industries).

The CMPTI provides eligible recipients with a refundable tax offset of 10 per cent of the eligible costs of processing certain critical minerals in Australia.

2 September

CA2024-012_Housing_(Build-To-Rent Developments)accelerating_tax_deductions_and_reducing_managed_investment_trust_withholding_tax_rate.pdf Now received Royal Assent

<u>CA2026-002 Hydrogen Production tax incentive (HPTI).pdf</u> (Future Made in Australia – accelerating investment in Australian industries)

The HPTI is to help companies commence medium to large scale production of renewable hydrogen in Australia, while the market is still developing.

CA2026-003 Reportable Tax Position Schedule expansion to large superannuation funds and collective investment vehicles.pdf

9 September

CA2024-013_Extending the clean building managed investment trust withholding tax concession.pdf
Now has a revised start date announced in the last budget - 1st day of the quarter following amending law Royal Assent.

TRT bug fixed in July EVTE and PayEvent bugs in August EVTE will be deployed into production

September EVTE release 19 September

- OECD Pillar 2 changes (LDG.List, TXLST, CLNTACC, CLNTACCSUM) will be published with their code deployed to EVTE as well. CUREL to be released as a part of October release
- ASMT PCN update to resolve a known issue. No code or artefact changes as the bug was internal to the ATO

Weekend Release Update:

Our standard September systems release is scheduled for this weekend. Several planned changes for Online Services for Agents (OSFA) have been deferred and will be rescheduled.

SBR2 Maintenance (20-22 September 2025):

Critical maintenance for SBR2 will occur from 10:00pm Saturday 20 September to 7:00am Monday, 22 September. This outage was originally planned to end at 10:00am Sunday however has been extended to allow sufficient time for rollbacks if required. If the system updates are completed ahead of schedule

SBR2 will be made available sooner. ATO online services such as Online Services for Agents (OSFA) and Online Services for Business (OSB) will be available. We've updated our web maintenance pages and dashboard notifications and have communicated these changes to agents via our weekly newsletter.

While the extension is not ideal due to the monthly BAS due date falling on Sunday, 21 September, the due date will automatically shift to the next business day as per standard practice.

ATO online services login Issues:

Some agents have reported system unavailable errors when accessing ATO Online Services. This may be linked to the Australian Government Digital Identity System (AGDIS) and is not an ATO system issue as it is not believed to be related to myID specifically. We are actively working with AGDIS and affected agents to investigate and resolve the issue. AGDIS advised agents to ensure they log out correctly to ensure the session closed properly and regularly clearing their browsers cache.
