- Addition of PayId element for NPP.

Schedule 3 – Payment Methods

Section 2

- Receiving solutions must be able to accept NPP payments by 1 July 2026, with ability for receiving solutions to opt-in sooner.
- Lifted “Generating the PRN” to a new section (which previously sat under BECS).
- Included a new, third, method of generating a PRN, called “Composite method”.
- Added detail on how NPP payments are to be treated
 - Requirements of the sender, including PRN and schema information
 - Specific reference to NPP PayTo instruction
