Note on terminology

The key words “MUST”, “MUST NOT”, “REQUIRED”, “SHALL”, “SHALL NOT”, “SHOULD”, “SHOULD NOT”, “RECOMMENDED”, “MAY”, and “OPTIONAL” in this document are to be interpreted as described in RFC 2119 <http://www.ietf.org/rfc/rfc2119.txt>. The use of the word “mandatory” is to be read as “MUST”.

1 INTRODUCTION

1.1 PURPOSE

This document defines the terms used in the documents incorporated by reference in the Schedules to the Superannuation Data and Payment Standards 2012 and the RSA¹ Data and Payment Standards 2013.

1.2 STANDARD BUSINESS REPORTING (SBR) TAXONOMY REFERENCE

- (a) The SBR Definitional Taxonomy which is available at <http://sbr.gov.au/taxonomy> must be used in conjunction with this document.
- (b) To avoid any doubt there is no change to a data element name even if the entity is an RSA provider.

Example - “SuperannuationFundDetails” is incorporated in a data element name. That same data element name is used if the entity is an RSA provider as it must remain consistent with the SBR Definitional Taxonomy.

1.3 EXPLANATION OF TERMS

Business Terms used in superannuation transactions and referenced in the Taxonomy are defined in the table set out in section 2 of this document. The elements that make up the business transaction are:

Element of Business Term	Description
Definition	The plain English definition of the business term. For context, this should always be read in conjunction with the ‘term legal reference’.
Data element name	The technical name which corresponds to a business term and is used by programmers in constructing a taxonomy instance or schema.
Term legal reference	The legislative or regulation reference (if any) which provides an authoritative definition of the business term.
Unique reference ID	The reference number assigned in the Taxonomy which uniquely identifies each business term.
Term version no.	The version number assigned in the Taxonomy which indicates the versioning reference of the term. As a term or its definition is changed, a new version number will be assigned.
